## 2025 Community Health Needs Assessment

### *Insight into Thomas H. Boyd Memorial Hospital's population*

Provisions in the Affordable Care Act (ACA) require charitable hospitals to conduct a Community Health Needs Assessment (CHNA). The CHNA is a systematic process involving the community to identify and analyze community health needs as well as community assets and resources in order to plan and act upon priority community health needs.

This assessment process results in a CHNA report that assists the hospital in planning, implementing, and evaluating hospital strategies and community benefit activities. The Community Health Needs Assessment was developed and conducted in partnership with representatives from the community.

This Community Health Needs Assessment will serve as a guide for planning and implementation of healthcare initiatives that will allow the hospital and its partners to best serve the emerging health needs of Greene County and the surrounding area.

### Introduction

Thomas H. Boyd Memorial Hospital dba Boyd Healthcare Services is a 25 bed not for profit Critical Access Hospital. It was opened in September 1941, as an acute care hospital and in 1999 became the first critical access hospital in the State of Illinois. The hospital is licensed by the Illinois Department of Public Health. The hospital maintains a medical unit with a 24-hour Emergency Room Department. We provide primary care in four hospital based certified rural health clinics in three communities in the county. We also manage the only ambulance service located in Greene County. The hospital employees over 140 employees.

Thomas H. Boyd Memorial Hospital completed four Community Health Needs Assessments prior to 2025. The first CHNA was conducted in 2013 and it identified four different needs:

1. Basic wellness services, education and access for all residents
2. Mental Health Issues
3. Addressing access to quality local health care
4. Teen pregnancy

The second CHNA was conducted in 2016 and identified three needs:

1. Wellness and Prevention
2. Mental Health and Substance Abuse
3. Education on key areas: Diabetes, Congestive Heart Failure, Chronic Obstructive pulmonary Diseased, Cardiovascular Disease/Stroke and Cancer

The third CHNA conducted in 2019 identified four needs:

1. Mental Health
2. Substance Abuse/Controlled Substance Drugs
3. Local access to specialist services via telehealth.
4. Community Education

The fourth CHNA conducted in 2022 identified five needs.

1. Disease Education
2. Access to free exercise
3. Specialty Clinics
4. More/Better Engagement with Other Healthcare Organizations and Youth
5. An Additional Clinic & Walk-In Clinic

In response to these prior needs assessments, Thomas H. Boyd Memorial Hospital:

- Implemented an indoor walking trail
- Added Locust Street Resource Center with staff here at the hospital weekly
- Added new physicians and mid-level providers to the four hospital based certified rural health clinics
- Offered tele-health services through STAT STROKE and STAT HEART
- Offered tele-health clinic services
- Obtained grants on the reduction of salt throughout the hospital, schools and public
- Offered educational programs on Stroke, Diabetes, Heart Disease, Alzheimers and COPD
- Offered yearly health fair with testing and educational materials
- Have begun offering classes in different areas of the county
- Working with Locust Street to have a substance abuse counselor in the County 3 days a week
- Working with local staff to address prescription abuse. Have medication agreements, utilize the prescription monitoring program, and drug testing.
- Established a Chronic Care Management program and a Transitional Care management program
- Brought a pediatrician on at our Greene County Rural Health Clinic
- Partnered with Springfield Clinic to bring Cardiology & Vascular Care specialists to Boyd
- Offers Senior Life Solutions through PNC to provide outpatient mental health services to older adults

## Executive Summary

Thomas H. Boyd Memorial Hospital dba Boyd Healthcare Services conducted a Community Health Needs Assessment (CHNA) in 2025. Administration worked to complete this process to identify and analyze the community's health needs and update the community's resources to prioritize the health needs of our community. The CHNA is influenced by the large rural service area of Thomas H. Boyd Memorial Hospital.

The health profile of the service area of Thomas H. Boyd Memorial Hospital is influenced by the following indicators of social determinants of health:

1. Poverty – Children living in poverty
2. Poverty – Population below 100% of Federal Poverty Level
3. Unemployment
4. Access to mental healthcare
5. Access to dental care of low income, underinsured and uninsured

## Community Health Needs Assessment Population

A total of 65,656 people live in the 1,910.63 square mile report area defined for this assessment according to the U.S. Census Bureau American Community Survey 2019-2023 5-year estimates. The population density for this area, estimated at 34 persons per square mile, is less than the national average population density of 94 persons per square mile.

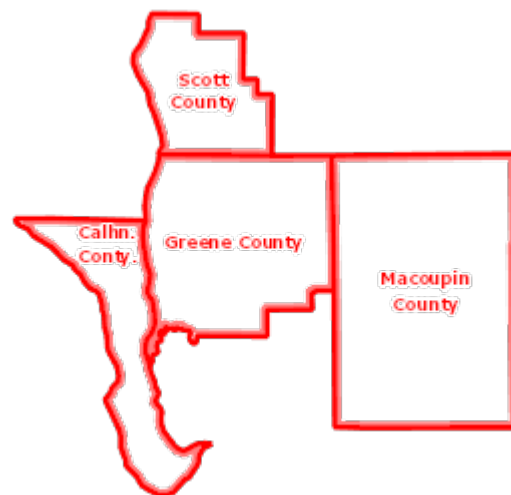

## Housing & Families

This category contains indicators that describe the structure of housing and families, and the condition and quality of housing units and residential neighborhoods. These indicators are important because housing issues like overcrowding and affordability have been linked to multiple health outcomes, including infectious disease, injuries, and mental disorders. Furthermore, housing metrics like home-ownership rates and housing prices are key for economic analysis.

**Households – Overview** - This indicator reports the total number and percentage of households by composition (married couple family, nonfamily, etc.). According to the American Community Survey subject definitions, a family household is any housing unit in which the householder is living with one or more individuals related to him or her by birth, marriage, or adoption\*. A non-family household is any household occupied by the householder alone, or by the householder and one or more unrelated individuals.

*\*Family households and married-couple families do not include same-sex married couples even if the marriage was performed in a state issuing marriage certificates for same-sex couples. Same sex couple households are included in the family households category if there is at least one additional person related to the householder by birth or adoption.*

**Housing Quality - Substandard Housing** - This indicator reports the number and percentage of owner- and renter-occupied housing units having at least one of the following conditions: 1) lacking complete plumbing facilities, 2) lacking complete kitchen facilities, 3) with 1 or more occupants per room, 4) selected monthly owner costs as a percentage of household income greater than 30%, and 5) gross rent as a percentage of household income greater than 30%. Selected conditions provide information in assessing the quality of the housing inventory and its occupants. This data is used to easily identify homes where the quality of living and housing can be considered substandard. Of the 25,199 total occupied housing units in the report area, 4,752 (18.86%) have one or more substandard conditions.

## Other Social & Economic Factors

Economic and social insecurity often are associated with poor health. Poverty, unemployment, and lack of educational achievement affect access to care and a community's ability to engage in healthy behaviors. Without a network of support and a safe community, families cannot thrive. Ensuring access to social and economic resources provides a foundation for a healthy community.

**Area Deprivation Index** - This indicator reports the average (population weighted) Area Deprivation Index (ADI) for the selected area. The Area Deprivation Index ranks neighborhoods and communities relative to all neighborhoods across the nation (National Percentile) or relative to other neighborhoods within just one state (State Percentile). The ADI is calculated based on 17 measures related to four primary domains (Education; Income & Employment; Housing; and Household Characteristics). The overall scores are measured on a scale of 1 to 100 where 1 indicates the lowest level of deprivation (least disadvantaged) and 100 is the highest level of deprivation (most disadvantaged).

**Households with No Motor Vehicle** - This indicator reports the number and percentage of households with no motor vehicle based on the latest 5-year American Community Survey estimates.

**Calhoun County** reports 1,222 Total Occupied Households. 36 (2.95%) of those are without a motor vehicle.

**Greene County** reports 4,514 Total Occupied Households. 181 (4.01%) of those are without a motor vehicle.

**Macoupin County** reports 17,431 Total Occupied Households. 788 (4.52%) of those are without a motor vehicle.

**Scott County** reports 2,032 Total Occupied Households. 77 (3.79%) of those are without a motor vehicle.

**Insurance - Uninsured Population (ACS)** - The lack of health insurance is considered a *key driver* of health status. This indicator is relevant because lack of insurance is a primary barrier to healthcare access including regular primary care, specialty care, and other health services that contributes to poor health status.

**SNAP Benefits - Population Receiving SNAP (SAIPE)** - The Supplemental Nutrition Assistance Program, or SNAP, is a federal program that provides nutrition benefits to low-income individuals and families that are used at stores to purchase food. This indicator reports the average percentage of the population receiving SNAP benefits during the month of July during the most recent report year.

These factors describe a community's social vulnerability.

The social vulnerability index is a measure of the degree of social vulnerability in counties and neighborhoods across the United States, where a higher score indicates higher vulnerability.

# Physical Environment

A community’s health also is affected by the physical environment. A safe, clean environment that provides access to healthy food and recreational opportunities is important to maintaining and improving community health.

## Built Environment - Broadband Access –

This indicator reports the percentage of population with access to high-speed internet. Data are based on the reported service area of providers offering download speeds of 25 MBPS or more and upload speeds of 3 MBPS or more. These data represent both wireline and fixed/terrestrial wireless internet providers. Cellular internet providers are not included.

## Clinical Care and Prevention

A lack of access to care presents barriers to good health. Supply of facilities and physicians, the rate of uninsurance, financial hardship, transportation barriers, cultural competency, and coverage limitations affect access.

Rates of morbidity, mortality, and emergency hospitalizations can be reduced if community residents access services such as health screenings, routine tests, and vaccinations. Prevention indicators can call attention to a lack of access or knowledge regarding one or more health issues and can inform program interventions.

**Cancer Screening - Mammogram (Medicare)** - This indicator reports the percentage of female Medicare beneficiaries age 35 and older who had a mammogram in most recent reporting year. The American Cancer Society recommends that women age 45 to 54 should get a mammogram every year, and women age 55 and older should get a mammogram every other year.

# Health Behaviors

Health behaviors such as poor diet, a lack of exercise, and substance abuse contribute to poor health status.

**Alcohol - Heavy Alcohol Consumption** - Data for this indicator were based on survey responses to the 2022 Behavioral Risk Factor Surveillance System (BRFSS) annual survey and are used for the 2025 County Health Rankings.

Excessive drinking is defined as the percentage of the population who report at least one binge drinking episode involving five or more drinks for men and four or more for women over the past 30 days, or heavy drinking involving more than two drinks per day for men and more than one per day for women, over the same time period. Alcohol use is a behavioral health issue that is also a risk factor for a number of negative health outcomes, including: physical injuries related to motor vehicle accidents, stroke, chronic diseases such as heart disease and cancer, and mental health conditions such as depression and suicide. There are a number of evidence-based interventions that may reduce excessive/binge drinking; examples include raising taxes on alcoholic beverages, restricting access to alcohol by limiting days and hours of retail sales, and screening and counseling for alcohol use disorder (Centers for Disease Control and Prevention, Preventing Excessive Alcohol Use, 2020).

**Physical Inactivity** - Within the report area, 9,044 (16.36%) of adults aged 20 and older self-report no active leisure time, based on the question: "During the past month, other than your regular job, did you participate in any physical activities or exercises such as running, calisthenics, golf, gardening, or walking for exercise?" This indicator is relevant because current behaviors are determinants of future health and this indicator may illustrate a cause of significant health issues, such as obesity and poor cardiovascular health.

## Health Outcomes

Measuring morbidity and mortality rates allows assessing linkages between social determinants of health and outcomes. By comparing, for example, the prevalence of certain chronic diseases to indicators in other categories (e.g., poor diet and exercise) with outcomes (e.g., high rates of obesity and diabetes), various causal relationship may emerge, allowing a better understanding of how certain community health needs may be addressed.

## Description of Data Sources

The following quantitative sources were reviewed for health information:

**Behavioral Risk Factor Surveillance System** – The BRFSS enables the Center for Disease Control and Prevention (CDC), state health departments, and other health agencies to monitor modifiable risk factors for chronic diseases and other leading causes of death.

**US Census** – National census data is collected by the US Census Bureau every 10 years.

**Centers for Disease Control** – Through the CDC's National Vital Statistics System, states collect and disseminate vital statistics as part of the US's oldest and most successful intergovernmental public health data sharing system.

**County Health Rankings** – Each year, the overall health of each county in all 50 states is assessed and ranked using the latest publicly available data through a collaboration of the Robert Wood Johnson Foundation and the University of Wisconsin Population Health Institute.

**Community Commons** – Community Commons is an interactive mapping, networking and learning utility for the broad-based health, sustainable and livable communities' movement.

**Illinois Department of Employment Security** – The Illinois Department of Employment Security is the state's employment agency. It collects and analyzes employment information.

**National Cancer Institute** – The National Cancer Institute coordinates the National Cancer Program, which conducts and supports research, training, health information dissemination, and other programs with respect to the cause, diagnosis prevention, and treatment of cancer, rehabilitation from cancer, and the continuing care of cancer patients and the families of cancer patients.

**HRSA** – The Health Resources and Services Administration of the U.S. Department of Health and Human Services develops health professional shortage criteria for the nation and uses that data to determine the location of Health Professional Shortage Areas and Medical Underserved Areas and Populations.

**ESRI** – Allows for specialized inquiries at the zip code or other defined level.

**Illinois State Board of Education** – This administers public education in the state of Illinois that release the make-up, needs and performances of local schools.

**Local IPLANS** – The Illinois Project for Local Assessment of Needs (IPLAN) is a community health assessment and planning process that is conducted every five years by local health jurisdictions in Illinois.

**USDA**- It collects and analyzes information related to nutrition and local production and food availability.

## Qualitative Data

Qualitative Data was reviewed to help validate the selection of health priorities. In alignment with IRS Treasury Notice 2011-52,2 and the subsequent final rules reported at 79 FR 78953, the qualitative/primary data received and reviewed included primary input from (1) At least one state, local, tribal or regional governmental public health department (or equivalent department or agency) with knowledge, information, or expertise relevant to the health needs of the community and, (2) members of medically underserved, low-income and minority populations in the community or individuals or organizations serving or representing the interests of such populations.

No written comments were received concerning the hospital facility's most recently conducted CHNA nor on the most recently adopted implementation strategy.

Data was also gathered representing the broad interests of the community. The hospital took into account input from persons who represent the broad interest of the community served by the hospital, including those with special knowledge of, or expertise in public health (local, regional, state and/or tribal).

Members of the CHNA committee, who participated in focus groups and the needs identification and prioritization process, were chosen based on their unique expertise and experience, informed perspectives, and involvement with the community.

## Description of the Community Health Needs Identified

### **Focus Groups:**

The first focus group met on October 2nd in Carrollton. The community issues discussed were:

- Preventive screening and early detection
- Mental and behavioral health access
- Local specialty and follow-up care

The second focus group met on October 8th in White Hall. The community issues discussed were:

- North Greene Walk-In Clinic
- EMS Stationed in North Greene
- Mental-health support and parent education on adolescent mental health

The third focus group met on October 16th in Greenfield. The community issues discussed were:

- Additional pediatric care
- Additional specialty care
- Preventive screening and early detection



## Implementation Strategies:

1. Preventive screening and early detection
  - a. To expand access to preventive care, we will host a community health fair offering on-site screenings at affordable out-of-pocket rates.
2. Mental and behavioral health access
  - a. We plan to strengthen access to mental and behavioral health services by hiring a medical provider specializing in family mental health.
3. Local specialty and follow-up care/Additional specialty care
  - a. We will continue partnering closely with specialty providers to bring more services directly to the community and reduce the need for travel.
4. North Greene Walk-In Clinic
  - a. Access to same-day care will be expanded by building a new walk-in clinic in White Hall, scheduled to open in 2026.
5. EMS Stationed in North Greene
  - a. To improve emergency response times, EMS crews will be stationed at the upcoming White Hall Walk-In Clinic.
6. Mental-health support and parent education on adolescent mental health
  - i. We will work to improve awareness and understanding of adolescent mental health by enhancing education for our staff and sharing relevant resources with the community. We will seek opportunities to collaborate with local schools and organizations when appropriate to help families access reliable information and support.
7. Additional pediatric care
  - a. With a Pediatric Physician already on staff, Boyd will expand pediatric services across all clinics by enabling all providers to practice pediatric care under Dr. Uhles' supervision.
